This Privacy Statement is utilized by Bettr Health Group B.V.

Through our websites bettr-group.com and all its affiliated websites, including bettr-health.com, bettr-solutions.com, and bettr-finance.com, we collect information. In this statement, we delve into the information gathering process during visits to our websites. We uphold your privacy and ensure that any personal information you provide is handled confidentially. Processing of personal data adheres to the guidelines of the General Data Protection Regulation. We've implemented security measures to safeguard your personal data, both technically and organizationally. This privacy statement outlines our approach to handling personal data.

Purposes and Legal Basis of Data Processing

We use personal data to process your inquiries, grant you access to specific information, send you digital newsletters, or provide you with the opportunity to utilize the functionalities and services on our websites. Data Processed

- Click Behavior and Visit Data

General visit data may be tracked on our websites. In this context, the IP address of your computer, any username, the internet browser used, or the operating system used, the number of visits, the average time spent on the website, the time of retrieval, the data sent by the visitor's browser, and the pages visited may be recorded and used for statistical analyses of website visit and click behavior. This data is

also used to optimize the functioning of the websites. We endeavor to anonymize this data as much as possible.

We do not collect or use special personal data for segmentation purposes.

Retention Periods

If you fill out a contact form on the websites, sign up in another way, use our services, or send us an email, the data you send us will be retained for as long as necessary given the nature of the form, the content of your email, or the execution of our service, for the full answering and handling thereof. Retaining the data may also be necessary to comply with our legal obligations, settle disputes, and fulfill our agreements.
